**Important: Please read these rules before entering this Sweepstakes (the “Sweepstakes”).**

**By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.**

Sweepstakes void where prohibited by law. Subject to all federal, state, and local laws, regulations, and ordinances.

**1. Eligibility:** The Sweepstakes is open only to individuals who are legal U.S. residents currently residing in the 50 United States and the District of Columbia, who are at least 18 years old (or the age of majority in their jurisdiction, whichever is older) at the time of entry. Directors, officers and employees of Flatiron Media, LLC (“**Sponsor**”) and any of its respective parent companies, affiliate companies, subsidiaries, agents, professional advisors, advertising, promotional, public relations, and fulfillment agencies, consultants, legal counsel, website providers, web masters, and immediate family members (spouses, parent, child, sibling, grandparent, and/or stepchild, wherever they may live) of each are not eligible to win any prize. **IF YOU DO NOT MEET ANY OF THESE REQUIREMENTS, OR ANY OTHER ELIGIBILITY REQUIREMENTS IN THESE OFFICIAL RULES, YOU ARE NOT ELIGIBLE TO WIN A PRIZE.** To be eligible to win a prize, entries must be completed and received by Sponsor in the manner and format designated below.

**2. Sweepstakes Period:** The Sweepstakes starts at **12:00:01am ET on January 1, 2026** and ends at **11:59:59pm ET on December 31, 2026** (the “**Sweepstakes Period**”). All entries must be received during the Sweepstakes Period and meet other requirements in these Official Rules to be eligible to win a prize. Sponsor’s or its designee’s computer is the official time-keeping device for the Sweepstakes. The Sweepstakes Period consists of separate daily sweepstakes. Entries into a daily sweepstakes are valid only for the day in which the entries are received and do not roll over into future daily sweepstakes.

**3. How to Enter:** To enter, during the Sweepstakes Period, complete the steps in any of the following methods of entry for a daily Sweepstakes entry:

**Sponsor Website Method of Entry:** (1) Go to any of the Sponsor’s websites (the “Websites”) and provide the requested information (e.g., your name and email address) in the daily Sweepstakes entry form; in certain situations, we already have your personal information so we may not ask for it. In these situations, follow the other instructions as outlined here and you will be entered into the sweepstakes; and (2) follow the instructions to view the sales offers on the Websites until you reach the final confirmation page.

**Partner Website Method of Entry:** (1) Go to the website of an authorized partner of Sponsor (the “Partner Websites”) and provide the requested information (e.g., your name and email address) in the daily Sweepstakes entry form; in certain situations, we already have your personal information so we may not ask for it. In these situations, follow the other instructions as outlined here and you will be entered into the sweepstakes; and (2) follow the instructions to view the sales offers on the website until you reach the final confirmation page.

**Other Methods of Entry:** From time to time, Sponsor may offer additional methods of entry for a daily Sweepstakes. Follow the instructions specified by Sponsor or its designee for entry.

**LIMIT: THREE ENTRIES PER PERSON PER DAY REGARDLESS OF METHOD OF ENTRY.** Any attempt to obtain additional entries, including through multiple or duplicate accounts will result in disqualification. **You are not eligible to win if you have won a prize from Sponsor through a Sponsor or Partner Website Sweepstakes in the preceding 90 days.**

**4. Identity of Entrant:** All entries must be submitted by the individual entrant. Bulk or automated entries will be disqualified (including, for example, entries made using any script, macro, bot, or sweepstakes service). If entrant attempts multiple entries with different credentials, the Sponsor reserves the right to disqualify entries associated with the entrant information/email address(es) involved. Multiple participants are not permitted to share the same email address.

In the event of a dispute about the identity of the entrant, entries made online will be declared made by the authorized account holder of the e-mail address submitted at time of entry. An “authorized account holder” means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., 144340304.1

business or educational institution) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide Sponsor with proof that the potential winner is the authorized account holder of the e-mail address associated with the winning entry.

**5. Selection and Notification of Winner:** 365 winners will be selected during the Sweepstakes Period. Every day beginning on January 2, 2026 (the second day of the sweepstakes), Sponsor will select the name of one potential winner from the previous day's entries in a random drawing among all eligible entries at Sponsor's headquarters located as listed in Section 15 below. During the Sweepstakes Period, the pool of entrants will reset daily, and Sponsor will select from the new pool of entrants the following day. For the avoidance of doubt, each day's pool of entries will run from 12:00:00 (midnight) ET through 11:59:59 ET (first day begins at 12:00:01 ET). The odds of winning depend on the number of eligible entries received.

Each potential winner will be notified via email. To the fullest extent permitted by applicable law, each potential winner may be required to sign and return, within seven days of being notified, an Affidavit of Eligibility and Liability/Publicity Release and/or tax forms, and may be required to submit a photo of themselves and write a short statement about winning the prize in order to claim his/her prize. If (i) the attempted notification is returned as undeliverable without a forwarding address; (ii) any requested documents are not returned within seven days, including but not limited to the Affidavit of Eligibility and Liability/Publicity Release or tax forms; or (iii) if winner is otherwise unable to accept the prize as stated, the prize will be forfeited and may be awarded to an alternate winner. Only two alternate drawings will be held for each day, after which that day's prize will remain unrewarded. If, by reason of a print or other error, more prizes are claimed than the number set forth in these Official Rules, an alternate winner will be selected in accordance with the above selection process from among all eligible claimants making purportedly valid claims to award the stated number of prizes available.

**Verification of Potential Winner:** The potential winner is subject to verification by Sponsor, whose decisions related to the Sweepstakes are final and binding. An entrant is not a winner of the prize unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete.

**6. Prize:** Each day (for 365 days), one winner will receive one \$500 gift card for the brand displayed on the webpage on which he or she enters (available gift cards and brands will vary). Follow instructions upon notification to select, verify, and receive prize. A follow-up email will be sent once the gift card has been delivered, advising the winner to check their inbox, including the junk or spam folder. The gift card can be redeemed for either a virtual or physical card; however, a \$3 fee will be deducted from the total value of the card if a physical card is selected. The combined total approximate retail value of all prizes during the Sweepstakes Period is \$182,500.

**Limit:** If you have won a prize in an Sponsor Sweepstakes within the preceding 90 days, you are not eligible to win a prize. For clarity, you may participate in a Sweepstakes and be eligible again after 90 days have passed from the date you won the prize.

**Prize Restrictions:** ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZE ARE THE SOLE RESPONSIBILITY OF THE WINNER. Prize is not transferable. Only the stated number of prizes are available to be won in the Sweepstakes. Except for applicable manufacturer's standard warranties, prize is awarded "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose).

**7. Disclaimer:** Sponsor and any of its respective parent companies, subsidiaries, affiliates, directors, officers, professional advisors, consultants, contractors, legal counsel, public relations firms, employees and advertising, fulfillment and marketing agencies (collectively, the "**Released Parties**") will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) telephone, electronic, hardware, software, network, Internet, or other computer or communications-related malfunctions or failures beyond Sponsor or the Release Parties' reasonable control; (c) any Sweepstakes disruptions, injuries, losses or damages caused by events beyond the reasonable control of Sponsor or the Released Parties by non-authorized human intervention; or (d) any printing or typographical errors in any materials associated with the Sweepstakes.

TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL THE SPONSOR AND THE RELEASED PARTIES BE LIABLE FOR ANY SPECIAL, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, LOSS OF USE, LOSS OF PROFITS OR LOSS OF DATA, WHETHER IN AN ACTION IN CONTRACT, TORT (INCLUDING, BUT NOT LIMITED TO, NEGLIGENCE) OR OTHERWISE, ARISING OUT OF OR IN ANY WAY CONNECTED TO YOUR PARTICIPATION IN THE SWEEPSTAKES OR USE OR INABILITY TO USE ANY EQUIPMENT PROVIDED FOR USE IN THE SWEEPSTAKES OR ANY PRIZE, EVEN IF A RELEASED PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
